

Disney Explorers Lodge Special Room Offer for Designated Associations

Terms and conditions

- This offer is only available to the members of associations designated by Hongkong International Theme Parks Limited ("HKITP") (such members, "Eligible Guests"). Eligible Guests are required to present his/her valid membership card and personal photo identification for verification upon check-in. Otherwise, the prevailing room rate at the time of check-in will be charged.
- 2. This offer is valid for check-in dates from September 1 to September 30, 2018 with check-out date on or before October 1, 2018, except for September 25 and September 26, 2018 which are block-out dates.
- 3. This offer is applicable for Standard Room and Sea View Room in Disney Explorers Lodge ("Hotel") only.
- 4. Actual offer price depends on the check-in and check-out date, the room category selected, the number of staying Guests in the group and the respective ages of the staying Guests (subject to availability and any Benefits Limits as such term is defined in the Hotel General Terms and Conditions).
- 5. An extra charge of HK\$200 per person per night applies to the third and fourth Guests aged 12 or above staying in the same Hotel room.
- 6. Subject to Paragraph 5 above, each Hotel room can accommodate up to a maximum of 4 Guests. At least one adult must be a staying guest in each Hotel room.

- 9. Each Eligible Guest is entitled to reserve a maximum of one room within the same check-in and check-out date. A 3-day advance booking is required.
- 10. No change of guest name is allowed under any circumstances.
- 11. Guests are not allowed to cancel or amend a reservation once it is made. Any cancellation or amendment will be subject to a charge equivalent to the first night's room rate, extra charge (if any) and 10% service charge. Such charge will be deducted from the deposit.
